Dear Friends,

It all started with an inspirational biology teacher and his class' idea to travel to Kenya in Summer 2007 to visit his childhood village, witness life and living conditions there and help halt the spread of mosquito-borne malaria. Shortly thereafter, concerned students, teachers, parents and residents alike founded the all-volunteer **Hopewell-Keroka Alliance** (HKA) non-profit organization, following that first Hopewell Valley Central High School (HVCHS) student trip to this region of small villages within the rural tea-growing Keroka area of southwestern Kenya in East Africa.

The trip had a profound impact upon students and adult chaperones alike, the realities and disparities in daily living in bare between two distant communities, and a collaborative relationship and enduring friendship forged over time. Simply put, HKA seeks to build an ongoing humanitarian and cultural bridge between the Hopewell Valley and Keroka communities and to improve overall health, education and infrastructure for residents of multiple small villages within that particular small corner of Kenya. **HKA New Jersey** selects and manages its projects in conjunction with **HKA Keroka**, a sister non-profit organization comprised of community leaders and volunteers on the ground in Kenya.

Ten years later and almost \$170,000 raised in the United States in the interim, HKA volunteers of all ages have funded the following infrastructure-, health- or education-related improvements within Keroka's 10,000-resident Nyankoba Ward:

- Recent drilling of a first deep well to provide easier community access to water (research this past summer showed that local families currently spend an average four hours each day collecting water, even longer in the dry season).
- Construction of the area's first tea-buying center, speeding tea to market before wilting (tea is the main cash crop).
- Assisting with the construction and equipping of the area's first two health-care centers.
- Upgrading five miles of dirt tracks to 16-foot-wide, all-weather, stone-surfaced roads, with culverts and drainage.
- Facilitating electrical connection, wiring and lighting in 10 schools, the two health-care centers and tea-buying center.
- Not to mention installing rooftop rainwater-collection tanks on school and community buildings as on-site water sources, supplying educational or scientific equipment, textbooks and sports supplies to local schools, planting trees, and providing 5,000 mosquito bed nets for home use, dramatically decreasing the area's incidence of malaria.

We still have much more we wish to accomplish in support of our friends and neighbors in Kenya in the years ahead.
